Property Tax Exemption Filing Deadlines

Low Income Senior Exemption (RP-467) – Annual Renewals

Although the deadline for filing all other types of property tax exemption applications is May 01, 2020, please note that the *renewal* deadline for an important exemption available to [qualifying seniors](#), the Low Income Senior (RP-467) exemption, has been extended to June 16, 2020; *new* RP-467 applications remain due by May 01, 2020.

Both [new](#) and [renewal](#) Low Income Senior (RP-467) Exemption applications are available online, as are the [application instructions](#). Please also see the *Submitting Your Exemption Application(s)* section at the end of this press release.

Enhanced STAR, Veteran's, and other Exemptions

Below is a listing of other common exemptions, applications for which are due May 01, 2020, though [other exemptions may be available](#), depending on one's circumstances:

- [Enhanced STAR Exemption](#). [Eligible property owners](#) may apply for the [Enhanced Star](#), which also requires a [supplemental application](#). One may also visit the online [NYS Star Resource Center](#) for more information.
- [Alternative Veteran's Exemption](#) (RP-458(a)). This exemption is for qualified residential real property owned by veterans of defined periods of war, veterans who received expeditionary medals, or certain members of their family. [Instructions](#) and an [application](#) are available online.
- [Cold War Veteran's Exemption](#) (RP-458(b)). This exemption authorizes a limited exemption from real property taxes for real property owned by persons who rendered military service to the United States during the Cold War (defined as September 2, 1945, to December 26, 1991). [Instructions](#) and an [application](#) are available online.

Submitting your Exemption Application(s)

Please be advised that, with the exception of Low Income Senior Exemption Renewals noted in this press release, the application deadline for all Real Property Tax Exemptions is May 1, 2020.

Therefore, new and renewal exemption applications must be received in our office or postmarked no later than Friday, May 01, 2020.

Although Village Hall is presently closed in response to COVID-19 restrictions, please note that exemption applications and supporting documentation may be deposited in the Village Hall drop box, stationed to the right of the Village Hall front door, by [e-mail](#) or via regular mail to:
